**RESOLUTION 2020 - 92**

**A RESOLUTION DECLARING TOWNSHIP PROPERTY AS SURPLUS  
AND OBSOLETE AND AUTHORIZING ITS DISPOSITION, DISPENSING  
WITH A SECOND READING AND DECLARING AN EMERGENCY**

**WHEREAS**, the Board of Township Trustees of Sycamore Township desires to dispose of certain copier equipment most recently used by the Township Departments that is obsolete and no longer needed by the Township;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** The following item of Township equipment is hereby declared to be surplus property which is no longer needed by the Township and to be obsolete:

1. Sharp MX-M450N Copier, S/N 85046502 (Fire Department)
2. Sharp AR-M257 Copier, S/N 85028273 (Maintenance Department)
3. Sharp MX-M550N Copier, S/N 85004423 (Administration Department)

**SECTION 2.** The Township Administrator and Township Road Superintendent are hereby authorized and directed to dispose of such equipment in accordance with any method of disposal authorized by Ohio Revised Code Section 505.10.


