

RESOLUTION NO. 2020- 107

**A RESOLUTION ESTABLISHING RATES OF PAY AND BENEFITS
FOR TOWNSHIP EMPLOYEES**

WHEREAS, in order to establish rates of pay and benefits for employees of Sycamore Township;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. All full-time employees of Sycamore Township shall receive medical, dental, and life insurance benefits, vacation time, sick days, and personal days as established in the Employee Handbook as it may be amended from time to time except union employees shall receive benefits per their union contract if such benefits differ from the Employee Handbook.

SECTION 2. The following employees shall receive the compensation and benefits set opposite their respective names effective on December 27, 2020:

Members of the International Association of Fire Fighters Local 3907 Union shall be compensated pursuant to the contract between Sycamore Township and the Union which will be effective January 1, 2021.
