**RESOLUTION 2021 - 056**

**A RESOLUTION DESIGNATING NO PARKING ON PORTIONS OF MCCAULY ROAD AND TENDERFOOT LANE IN SYCAMORE TOWNSHIP**

**WHEREAS**, in order to provide for safe streets and roads in Sycamore Township, Ohio;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** Due to indiscriminate parking and to ensure the free movement of vehicles and emergency vehicles on McCauly Road and Tenderfoot Lane, dedicated roads in Sycamore Township, there shall be no parking on the east side of McCauly Road beginning at the intersection of Lewisclark Trail extending south a distance of 115 feet to the intersection of Tenderfoot Lane then extending east on the north side of Tenderfoot Lane for a distance of 140 feet.

**SECTION 2.** The Township Maintenance Department shall install the appropriate signage as required by law to enforce this Resolution.






