**RESOLUTION NO. 2021 - 080**

**A RESOLUTION RENEWING THE MCCAULY WOODS LIGHTING DISTRICT AND  
DISPENSING WITH THE SECOND READING**

**WHEREAS**, a contract and assessment for lighting the streets of McCauly Road, Lewisclark Trail, Bearvalley Court, and Coyote Court known as the McCauly Woods Lighting District, will expire on December 31, 2021.

**WHEREAS**, Ohio Revised Code Section 515.081 provides a Board of Township Trustees may award a new contract for lighting unless the owners of lots and lands containing more than fifty percent of the front feet abutting on the streets of the lighting district petition the board to discontinue the lighting district; and

**WHEREAS**, no such petition has been filed with regard to the McCauly Woods Lighting District; and

**WHEREAS**, a public hearing on the renewal of the lighting district was held on September 21, 2021, notice having first been given as required by statute;


**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, Hamilton County, State of Ohio:

- SECTION 1.** The McCauly Woods Lighting District which shall include the following streets: McCauly Road, Lewisclark Trail, Bearvalley Court, and Coyote Court, is hereby renewed.
- SECTION 2.** The costs of such lighting district shall be assessed against each parcel of real estate fronting on such streets in an amount equal to \$91.64 per parcel per year for each parcel bounding and abutting upon the streets so lighted.
- SECTION 3.** The assessment for such lighting shall be paid in five equal annual installments for five years and shall be paid and collected in the same manner in which real estate taxes are paid and collected.
- SECTION 4.** The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
- SECTION 5.** This resolution shall take effect on the earliest date allowed by law.




