- Section 2. Pursuant to O.R.C. §505.87, the owners and lien holders of record for the property shall be properly notified of this action and given seven days to abate the nuisance.
- Section 3. In the event the nuisance is not abated within the time period allowed, the maintenance department of the Township, or other designated party, is hereby directed to cut the vegetation and remove and discard the unattended garbage, refuse and other debris at the property located at 8285 FIELDS ERTEL ROAD, SYCAMORE TOWNSHIP, OH. 45249, AKA 12185 SNIDER ROAD, SYCAMORE TOWNSHIP, OH. 45249, Auditor's Parcel Number: 060000150008 and Sycamore Township Control Number SYCC210259.
- The owner of the property at 8285 FIELDS ERTEL ROAD, SYCAMORE TOWNSHIP, OH. 45249, AKA 12185 SNIDER ROAD, SYCAMORE TOWNSHIP, OH. 45249, Auditor's Parcel Number: 060000150008 shall be billed for such services and the Fiscal Officer shall place a special assessment on the real estate tax bill of the property if payment is not made within thirty days.
- Section 5. The Trustees of Sycamore Township upon majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
- **Section 6.** This Resolution shall take effect on the earliest date allowed by law.
