## <u>A RESOLUTION REQUESTING THE COUNTY AUDITOR TO MAKE ADVANCE</u> <u>PAYMENTS OF TAXES AND DISPENSING WITH A SECOND READING</u>

**WHEREAS**, the Ohio Revised Code allows a taxing authority to request payment from the County Auditor of funds derived from taxes or other sources paid to the County Treasurer, which may be held on account of a local subdivision;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, Hamilton County, State of Ohio:

- **SECTION 1.** That the Auditor and the Treasurer of Hamilton County, in accordance with Ohio Revised Code §321.34, be requested to draw and pay to Sycamore Township, upon the written request of Robert C. Porter, III, the Township's Fiscal Officer, to the County Auditor, funds due in any settlement of 2021 taxes payable in 2022 derived from taxes or other sources payable to the County Treasurer, which are being held on account of Sycamore Township, and lawfully applicable for purposes of the year January 1, 2022 through December 31, 2022.
- **SECTION 2.** That the Auditor and the Treasurer of Hamilton County be requested to draw and pay to Sycamore Township, upon the written request of Robert C. Porter, III, the Township's Fiscal Officer, funds due in 2021 in settlement of any estate taxes payable to the County Treasurer to the account of Sycamore Township.
- **SECTION 3.** That the Fiscal Officer shall forward to the County Auditor a certified copy of this Resolution.
- **SECTION 4.** The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
- **<u>SECTION 5.</u>** This Resolution shall take effect on the earliest date allowed by law.
