**RESOLUTION NO. 2022 - 001**

**A RESOLUTION RESCINDING RESOLUTION 2021-111 AND SETTING THE CORRECT RATES OF PAY FOR TOWNSHIP EMPLOYEES AND DISPENSING WITH A SECOND READING**

**WHEREAS**, in order to provide the correct compensation for full-time Township employees in Sycamore Township;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** All full-time employees of Sycamore Township shall receive medical, dental, and life insurance benefits, vacation time, sick days, and personal days as established in the Employee Handbook as it may be amended from time to time except union employees shall receive benefits per their union contract if such benefits differ from the Employee Handbook.

**SECTION 2.** Effective December 26, 2021, the following employees shall be compensated at the rate of pay set opposite his name:



**SECTION 6.** This resolution shall take effect immediately making the rates of pay effective on the date indicated.




