**RESOLUTION 2022 - 014**

**A RESOLUTION APPROVING A PROPOSAL FOR THE REPAIR OF A RETAINING WALL ON KENWOOD ROAD AND DISPENSING WITH A SECOND READING**

**WHEREAS**, the Board of Township Trustees wishes to provide for the repair, maintenance, and reconstruction of the retaining wall on Kenwood Road at the south entrance to the Kenwood Towne Centre and extending south approximately three hundred twenty feet (300'); and

**WHEREAS**, D.J. Stone Company submitted the lowest and best proposal for such repair, maintenance, and reconstruction; and

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** The Board of Township Trustees approves the attached proposal and a contract with D. J. Stone Company in substantially the same form as the proposal attached as Exhibit A. The Township shall pay one hundred percent (100%) of the cost of the project with no assessment for any property owner.

**SECTION 2.** Subject to additions and deletions contained therein, a contract is hereby approved in the amount of \$49,800.00 and the Interim Township Administrator or is hereby authorized and directed to execute the contract on behalf of the Board and the Township.

**SECTION 3.** The Township Trustees of Sycamore Township, upon at least a majority vote, do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

**SECTION 4.** This Resolution shall take effect on the earliest date allowed by law.
