RESOLUTION 2022 - 104

A RESOLUTION DECLARING TOWNSHIP PROPERTY AS SURPLUS AND OBSOLETE AND AUTHORIZING ITS DISPOSITION, DISPENSING WITH A SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the Board of Township Trustees of Sycamore Township desires to dispose of certain equipment that is obsolete and no longer needed by the Township;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Township equipment listed in the attached Exhibit A is hereby declared to be surplus property which is no longer needed by the Township and to be obsolete.

SECTION 2. The Township Administrator and Township Fire Chief are hereby authorized and directed to dispose of such equipment in accordance with any method of disposal authorized by Ohio Revised Code Section 505.10.

SECTION 3. The Board of Township Trustees of Sycamore Township, by at least a majority vote of all of its members, dispenses with any requirement that this Resolution be read on two separate days and authorizes its passage upon one reading.

SECTION 4. Upon Unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety, and welfare of Sycamore Township. The reason for the emergency is the need to dispose of obsolete property in a timely manner.




