**RESOLUTION 2023 - 005**

**A RESOLUTION APPROVING A CONTRACT FOR THE 2023 RECLAMITE ROAD REPAIR PROJECT AND DISPENSING WITH THE SECOND READING**

**WHEREAS**, the Board of Township Trustees has previously approved continuing in 2023 the project of treating pavements with Reclamite road repair material in order to prolong the life of streets and roads in the Township (“the 2023 Reclamite Road Repair Project”); and

**WHEREAS**, the Township is a participant in the Ohio Cooperative Purchasing Project and the Board has determined that advertising for bids for the 2023 Reclamite Road Repair Project would result in higher costs to the Township than purchasing the Reclamite process from the state bid through the Cooperative Purchasing Program; and

**WHEREAS**, Pavement Technology, Inc. submitted the lowest and best bid through the Ohio Cooperative Purchasing Program in which Sycamore Township participates;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** The attached proposal for the 2023 Reclamite Road Repair Project from Pavement Technology, Inc. in the amount of \$40,376.70 is hereby accepted and approved and the Township Administrator is hereby authorized and directed to contract with Pavement Technology, Inc. to provide for the 2023 Reclamite Road Repair Project.

**SECTION 2.** The contract with Pavement Technology, Inc. shall provide all of the necessary requirements in accordance with the proposal submitted by Pavement Technology, Inc. on the Ohio Cooperative Purchasing Program.

**SECTION 3.** Subject to additions and deletions contained therein, the contract price with Pavement Technology shall not exceed \$40,376.70.


**SECTION 4.** The Township Trustees of Sycamore Township, upon at least a majority vote, do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

**SECTION 5.** This Resolution shall take effect on the earliest date allowed by law.


