RESOLUTION PROVIDING FOR AND AUTHORIZING REMOVAL OF VEGETATION, GARBAGE, REFUSE AND OTHER DEBRIS AND DECLARING A NUISANCE FOR THE PROPERTY LOCATED AT 11949 3RD AVENUE, SYCAMORE TOWNSHIP HAM OH, OH 45249

WHEREAS, Ohio Revised Code §505.87 provides that a Board of Township Trustees may provide for the abatement and control over the removal of vegetation, garbage, refuse and other debris from land located in the Township; and

WHEREAS, the Board of Township Trustees of Sycamore Township has determined that the unattended vegetation, garbage, refuse and other debris on the property located at 11949 3RD AVENUE, SYCAMORE TOWNSHIP HAM OH, OH 45249, Auditor's Parcel Number: 060000110839 and Sycamore Township Control Number SYCC230169 is a nuisance;

NOW THEREFORE, Be It Resolved by the Board of Township Trustees, Sycamore Township, Ohio:

- Section 1. That the vegetation, garbage, refuse and other debris located on the property at 11949 3RD AVENUE, SYCAMORE TOWNSHIP HAM OH, OH 45249, Auditor's Parcel Number: 060000110839 is hereby declared to be a nuisance.
- Section 2. Pursuant to O.R.C. §505.87, the owners and lien holders of record for the property shall be properly notified of this action and given seven days to abate the nuisance.
- Section 3. In the event the nuisance is not abated within the time period allowed, the maintenance department of the Township, or other designated party, is hereby directed to cut the vegetation and remove and discard the unattended garbage, refuse and other debris at the property located at 11949 3RD AVENUE, SYCAMORE TOWNSHIP HAM OH, OH 45249, Auditor's Parcel Number: 060000110839 and Sycamore Township Control Number SYCC230169.
- Section 4. The owner of the property at 11949 3RD AVENUE, SYCAMORE TOWNSHIP HAM OH, OH 45249, Auditor's Parcel Number: 060000110839 shall be billed for such services and the Fiscal Officer shall place a special assessment on the real estate tax bill of the property if payment is not made within thirty days.
- Section 5. The Trustees of Sycamore Township upon majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
- Section 6. This Resolution shall take effect on the earliest date allowed by law.
