RESOLUTION 2023 - 081

**A RESOLUTION AUTHORIZING THE TRADE IN OF AN EXISTING BRUSH
BANDIT MODEL 100 AND DISPENSING WITH A SECOND READING**

WHEREAS, the Board of Township Trustees has authorized the purchase of one 2023 Intimidator 18XP (18" Drum Style) Brush Bandit; and

WHEREAS, the Board of Township Trustees has determined that the Equipment is available from Bobcat Enterprises on the Sourcewell purchasing program, a joint purchasing program as set forth in Ohio Revised Code Section 9.48 of which Sycamore Township is a member; and

WHEREAS, the Board of Township Trustees wishes to purchase the Equipment from Bobcat Enterprises; and

WHEREAS, the Board of Township Trustees owns a Brush Bandit Model 100 that is obsolete and unfit for public use and the Board desires to sell the unit to Bobcat Enterprises and to have the selling price of eight thousand dollars (\$8,000) credited against the purchase price of the new Brush Bandit pursuant to ORC 505.10(3); and

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Township Administrator is authorized to acquire the Equipment, through the Sourcewell joint purchasing program, from Bobcat Enterprises in an amount not to exceed \$93,449.60.

SECTION 2. The Trustees of Sycamore Township hereby finds that the Brush Bandit Model 100 currently owned by Sycamore Township is obsolete and unfit for public use and authorizes and directs that the unit be sold to Bobcat Enterprises and the selling price of eight thousand dollars (\$8,000) be credited against the purchase price of the new Brush Bandit.

SECTION 3. The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 3. This resolution shall take effect on the earliest date allowed by law.






