RESOLUTION 2023 - 095

**A RESOLUTION DESIGNATING NO PARKING ON A PORTION OF
HAPPINESS WAY IN SYCAMORE TOWNSHIP AND DISPENSING WITH A SECOND
READING**

WHEREAS, in order to provide for safe streets and roads in Sycamore Township,
Ohio;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees
of Sycamore Township, State of Ohio:

SECTION 1. Due to indiscriminate parking and to ensure the free movement of vehicles and emergency vehicles on Happiness Way, a dedicated road in Sycamore Township, there shall be no parking on the south side of Happiness Way, beginning 115 feet from the intersection of Happiness Way and Kenwood Road extending west a distance of 685 feet to the intersection of Happiness Way and Frolic Drive, and there shall be no parking for a fire lane on the north side of Happiness Way from the intersection of Happiness Way and Kenwood Road extending west a distance of 800 feet to the intersection of Happiness Way and Frolic Drive.

SECTION 2. The Township Maintenance Department shall install the appropriate signage as required by law to enforce this Resolution.


SECTION 3. The Board of Township Trustees of Sycamore Township, by at least two-third vote of all of its members, dispenses with any requirement that this Resolution be read on two separate days and authorizes its passage upon one reading.

SECTION 4. This Resolution shall take effect at the earliest possible date allowed by law.





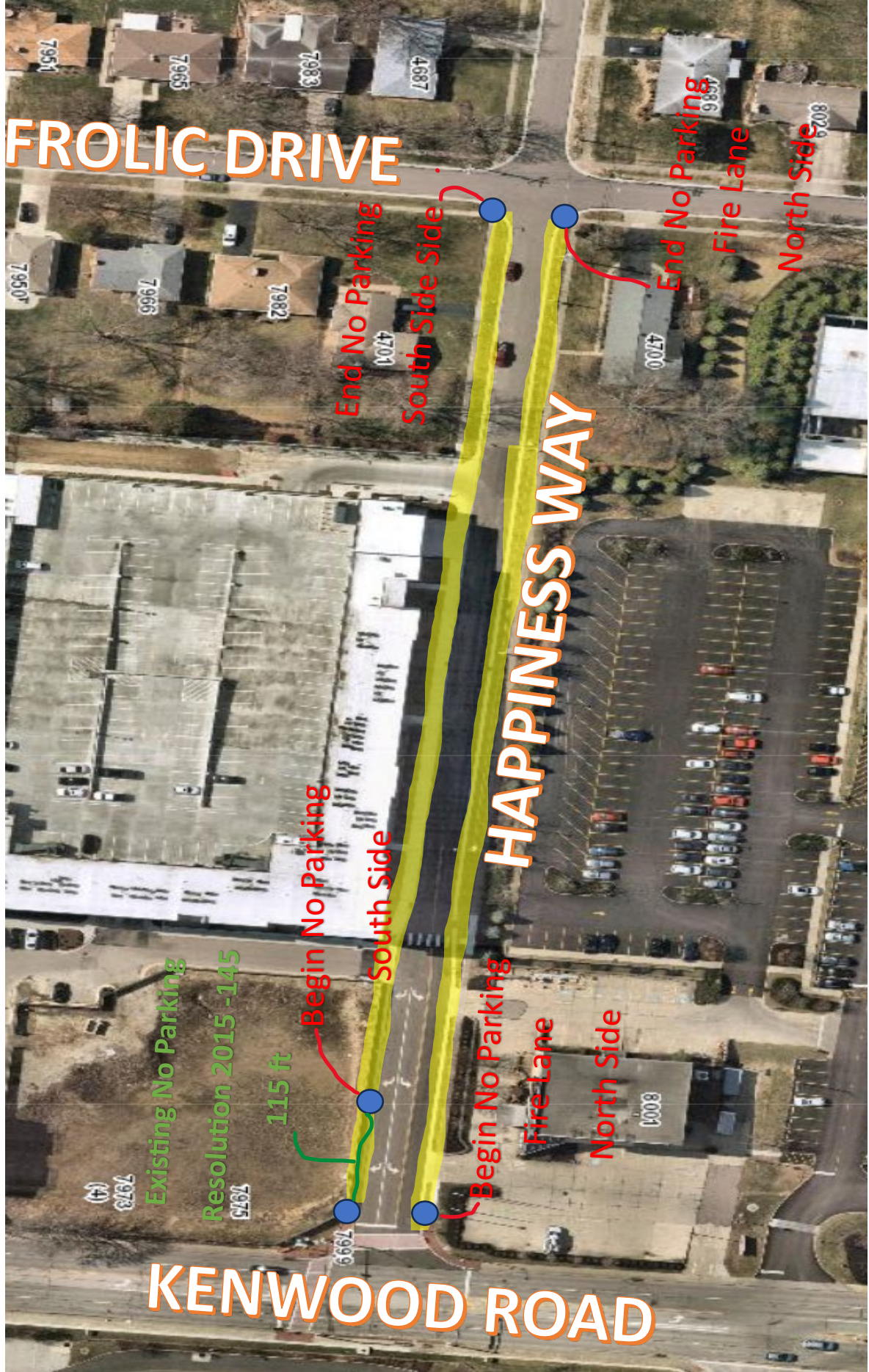
