# RESOLUTION NO. 2011 - 100

# A RESOLUTION AUTHORIZING THE SALE AND CLOSING OF THE REAL PROPERTY LOCATED AT 8460 KENWOOD ROAD IN SYCAMORE TOWNSHIP, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

**WHEREAS**, the Board of Township Trustees is desirous of selling the real property located at 8460 Kenwood Road, Sycamore Township, Ohio 45236;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

Pursuant to O.R.C. 505.10, the Board hereby unanimously authorizes the sale of the real property located 8460 Kenwood Road, Sycamore Township, Ohio 45236 to Tom Jones. The President of the Board, or the Township Administrator, or the Assistant Township Administrator are all hereby authorized individually to execute any documents necessary to obtain the conveyance of the property. The purchase price shall be \$120,500.00.

**SECTION 2.** 

The Trustees of Sycamore Township upon a unanimous vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

**SECTION 3.** 

This resolution shall take effect on the earliest date allowed by law.

**SECTION 4.** 

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety and welfare of Sycamore Township. The reason for the emergency is to provide for a timely closing and for the immediate provision of funds to the township.
