RESOLUTION NO. 2011 - 19

A RESOLUTION AMENDING RATES OF PAY AND BENEFITS FOR CERTAIN TOWNSHIP EMPLOYEES, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY

WHEREAS, Resolution 2010-99 established the rates of pay for 2011 for township employees; and

WHEREAS, the Board wishes to provide pay increases to certain employees for meritorious service.

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The portion of Section 3 of Resolution 2010-99 which reads as follows:

is deleted in its entirety. In its place is substituted as follows:

SECTION 2. These new rates of pay shall be effective May 1, 2011.

The increase in the pay rate of Chachoff to \$15.00 on December 27, 2010 pursuant to his obtaining his Commercial Driver's License per Resolution 2010-12 is hereby ratified.

All other provisions of Resolution 2010-99 not amended herein shall remain in full force and effect.

SECTION 5.

The Trustees of Sycamore Township, upon at least a majority vote, dispense with the requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

SECTION 6.

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety or welfare of Sycamore Township. The reason for the emergency is to provide wages in a timely manner to Township employees.
