# A RESOLUTION ELECTING TO BE EXCLUDED FROM PARTICIPATION IN THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the Board of Township Trustees of Sycamore Township has determined that it is not in the best interest of Sycamore Township to participate in the U.S. Department of Housing and Urban Development ("HUD")/Hamilton County Community Development Block Grant program;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTI	ON	1.

That Sycamore Township hereby elects to be excluded from the U.S. Department of Housing and Urban Development ("HUD")/Hamilton county Community Development Block Grant program for the three year period March 1, 2012 through February 28, 2015. HUD and Hamilton County shall exclude Sycamore Township from the program.

#### SECTION 2.

The Township Administrator is hereby authorized and directed to notify both the U.S. Housing and Urban Development Area Office and Hamilton County of this election no later than June 24, 2011.

#### **SECTION 3.**

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

#### **SECTION**

#### **SECTION 4.**

This resolution shall take effect on the earliest date allowed by law.

Sycamore Township. The reason for the emergency is to provide for a timely notification to HUD and Hamilton County.
