# RESOLUTION NO. 2011 - 40

# A RESOLUTION PROVIDING FOR NOTICE TO RESIDENTS OF INFORMATION FROM THE HAMILTON COUNTY SHERIFF REGARDING SEX OFFENDERS IN THE TOWNSHIP, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the Board of Township Trustees of Sycamore Township has established a policy of notifying residents living within three hundred feet of a registered sex offender as those persons are identified by the Hamilton County Sheriff pursuant to Ohio law; and

**WHEREAS**, the Board, in order to more fully protect the residents of Sycamore Township desires to establish the policy by resolution;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

#### SECTION 1.

Upon notification by the Hamilton County Sheriff that a registered sex offender has established a residence in Sycamore Township, or upon obtaining such knowledge from any other source, the township staff is authorized and directed to notify the residents located within three hundred feet of the location of the residence that a sex offender has established residence in the area and that more particular details may be obtained from the Hamilton County Sheriff's Office or the Sheriff's website.

#### **SECTION 2.**

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

#### **SECTION 3.**

This resolution shall take effect on the earliest date allowed by law.

#### **SECTION 4.**

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety and welfare of Sycamore Township. The reason for the emergency is to provide timely information to Sycamore Township residents.
