**SECTION 2.** Resolution 2006-37 passed June 1, 2006 and Resolution 2011-07 passed February 3, 2011 are deleted in their entirety.

SECTION 3. The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 4. This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare, and safety of the Sycamore Township. The reason for the emergency is to provide additional revenues to keep pace with increased costs incurred by the Township in administering the zoning resolution.
