In the event the nuisance is not abated within the time period allowed, the maintenance department of the Township is hereby directed to cut and control the weed and grass growth and remove other debris at the property located at 8916 Eldora Drive, Sycamore Township, Ohio 45236, Auditor's Parcel Number 060002330118.
- Section 4. The owner of the property at 8916 Eldora Drive, Sycamore Township, Ohio 45236, Auditor's Parcel Number 060002330118 shall be billed for such services and the Fiscal Officer shall place a special assessment on the real estate tax bill of the property if payment is not made within thirty days.
- Section 5. The Trustees of Sycamore Township upon majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
