RESOLUTION NO. 2011 - 9

A RESOLUTION PROVIDING A CIVIL FINE FOR OBSTRUCTING ROADS AND SIDEWALKS IN SYCAMORE TOWNSHIP

WHEREAS, pursuant to O.R.C. 5571.02 a Board of Township Trustees shall have control of township roads and is required to keep them in good repair; and

WHEREAS, the Township has experienced an increase in the dumping of gravel, building materials,

and landscaping materials on township roads causing obstructions to the travelling public and damage to roadway surfaces; and

WHEREAS, the Board of Township Trustees of Sycamore Township, pursuant to O.R.C. 504.05, wishes to establish a civil fine for dumping materials on township roads.

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

No owner, occupant, person having the care of any building or lot of land bordering on any township road or sidewalk, nor their agent, shall cause the same to be encumbered with barrels, boxes, cans, gravel, soil, mulch, or any articles, or substances of any kind, so as to damage such roads or sidewalks or cause interference with the free and unobstructed use thereof.

SECTION 2.

Whoever violates this Resolution shall be liable for a civil fine of \$350.00 for a first offense, \$700.00 for a second offense, and \$1,000.00 for a third offense and for each subsequent offense thereafter.

SECTION 3.

This resolution shall take effect on the earliest date allowed by law.
