RESOLUTION NO. 2013 - 111

A RESOLUTION AMENDING RATES OF PAY FOR PART-TIME MEMBERS OF THE SYCAMORE TOWNSHIP EMS AND FIRE DEPARTMENT, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY

WHEREAS, Resolution 2012- 113 passed December 5, 2012 established the rates of pay for part-time employees of the Sycamore Township EMS and Fire Department effective December 23, 2012; and

WHEREAS, enhanced safety services, which includes enhanced fire fighting and emergency medical services is part of the economic development plan established for all of the newly established Sycamore Township joint economic development zones; and

WHEREAS, the Board of Township Trustees wishes to begin the implementation of the plans for the Sycamore Township joint economic development zones; and

WHEREAS, the hiring of new part-time EMS and Fire Department personnel is necessary so as to increase personnel in the EMS and Fire Department in order to provide additional and enhanced EMS and fire services in all of the Sycamore Township joint economic development zones; and

WHEREAS, the Board of Township Trustees wishes to increase the rates of pay for parttime EMS and Fire Department personnel in order to attract additional personnel to enhance the safety services in the Sycamore Township joint economic development zones;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The portion of Section 3 of Resolution 2012 - 113 which reads as follows:

"Part-time EMS/Fire Department personnel shall be compensated at the rate of \$12.00 per hour." is hereby deleted.

In its place shall be substituted the following: "Part-time EMS/Fire Department personnel shall be compensated at the rate of \$13.00 per hour."

All other provisions of Resolution 2012-113 not amended herein and not previously amended shall remain in full force and effect.

SECTION 4. The Trustees of Sycamore Township, upon at least a majority vote, dispense with any requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first

reading.

SECTION 6.

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety or welfare of Sycamore Township. The reason for the emergency is to timely provide for the increase in personnel available to provide enhanced safety services in the Sycamore Township joint economic development zones.
