## RESOLUTION 2013-156

# A RESOLUTION AUTHORIZING A CONTRACT FOR ASPHALT SEALING AT BECHTOLD PARK, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the Board of Township Trustees is desirous of making improvements to the parking lot at Bechtold Park by sealing the asphalt; and

WHEREAS, the Township obtained estimates for the asphalt sealing at Bechtold Park; and

WHEREAS, Louiso Blacktop Maintenance submitted the lowest and best estimate for the asphalt sealing at Bechtold Park in the amount of \$8,960.00; and

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

#### **SECTION 1.**

The President of the Board or the Township Assistant Administrator is hereby authorized and directed to contract with Louiso Blacktop Maintenance to provide for the asphalt sealing project on the parking lot at Bechtold Park as set forth in the plans and specifications prepared by the Township for the project.

#### **SECTION 2.**

The contract with Louiso Blacktop Maintenance shall provide that the contractor shall provide and furnish all of the labor, materials, tools, expendable equipment, all utility, insurance and transportation services, all as required in accordance with the plans and specifications prepared by the Township for the asphalt sealing at Bechtold Park, which plans and specifications shall be made a part of such contract.

#### **SECTION 3.**

Subject to additions and deletions contained therein, the contract price with Louiso Blacktop Maintenance shall not exceed \$8,960.00.

#### **SECTION 4.**

The Board of Township Trustees of Sycamore Township, by at least twothird vote of all of its members, dispenses with the requirement that this Resolution be read on two separate days and authorizes its passage upon one reading.

### **SECTION 5.**

This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare, and safety of the Sycamore Township. The reason for the emergency is to immediately provide for protection of the parking lot at Bechtold Park before winter.
