A RESOLUTION AUTHORIZING THE 2017 ONYX ROAD REPAIR PROJECT AND DISPENSING WITH A SECOND READING

SECTION 1.

That the Board hereby approves the improvements and repairs for the 2017 Onyx Road Repair Project, which consists of the entire length of the following roads in Sycamore Township: Tiki Avenue, Lynnfield Court, Ginnala Drive, Quailhollow Drive, Michael Drive, Bobby Lane, Myrtlewood Avenue, Deerway Avenue, Glenover Drive, Appleknoll Lane, Malabar Terrace, Haverhill Lane, Highgate Place, Foxboro Court, Briarpatch Lane, Morganraiders Lane, Roundhill Lane, RaidersRun Road, PawPaw Lane, Stillmeadow Lane, Brittany Drive, Caralee Drive, Hemesath Drive, Autumnwood Drive, MiamiHills Drive, Lisa Lane, Dunlieth Court, Vinnedge Court, and Nodding Way.

SECTION 2.

The Board hereby determines that the entire cost of the project shall be paid by the Township with no assessments to be made, and approves the preparation of plans and specifications for the project.

SECTION 3.

The Board of Township Trustees of Sycamore Township, by at least twothird vote of all of its members, dispenses with any requirement that this Ordinance be read on two separate days and authorizes its passage upon one reading.

SECTION 4.

This Resolution shall take effect on the earliest date allowed by law.
