## A RESOLUTION AUTHORIZING A CONTRACT FOR THE MONTGOMERY ROAD SIDEWALK PHASE III PROJECT AND DISPENSING WITH A SECOND READING

WHEREAS, the Board of Township Trustees wishes to construct sidewalks along Montgomery Road between Galbraith Road and Kugler Mill Road in the Township (the "Montgomery Road Sidewalk Phase III Project"); and

WHEREAS, the Township caused plans and specifications for the Montgomery Road Sidewalk Phase III Project to be prepared and advertised for bids as required by state law; and

WHEREAS, Adleta Construction Company submitted a bid in the total amount of \$153,039.35 in accordance with the plans and specifications prepared by the Township; and

WHEREAS, the bid submitted by Adleta Construction Company was the lowest and best bid received;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** 

That the President of the Board and Fiscal Officer are hereby authorized and directed to contract with Adleta Construction Company to provide for the Montgomery Road Sidewalk Phase III Project as set forth in the plans and specifications prepared by the Township for the project.

**SECTION 2.** 

Such contract shall provide that Adleta Construction Company shall provide and furnish all of the labor, materials, tools, expendable equipment, and all utility, insurance and transportation services required in accordance with the plans and specifications prepared by the Township, which plans and specifications shall be made a part of such contract.

**SECTION 3.** 

Subject to additions and deletions contained therein, the contract price shall not exceed \$153,039.35.

**SECTION 4.** 

The Board of Township Trustees of Sycamore Township, by at least twothird vote of all of its members, dispenses with any requirement that this Ordinance be read on two separate days and authorizes its passage upon one reading.

**SECTION 5.** 

This Resolution shall take effect on the earliest date allowed by law.
