RESOLUTION NO. 2018 - 95

**A RESOLUTION RENEWING THE ORCHARD LANE LIGHTING DISTRICT AND  
DISPENSING WITH A SECOND READING**

**WHEREAS**, a contract and assessment for lighting Orchard Lane from Styrax Lane to Spirea Lane, known as the Orchard Lane Lighting District, is set to expire.

**WHEREAS**, Ohio Revised Code Section 515.081 provides a Board of Township Trustees may award a new contract for lighting unless the owners of lots and lands containing more than fifty percent of the front feet abutting on the streets of the lighting district petition the board to discontinue the lighting district; and

**WHEREAS**, no such petition has been filed with regard to the Orchard Lane Lighting District; and

**WHEREAS**, a public hearing on the renewal of the lighting district was held on September 12, 2018, notice having first been given by publication and hand delivery;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, Hamilton County, State of Ohio:

**SECTION 1.** The Orchard Lane Lighting District which shall include the following street: Orchard Lane from Styrax Lane to Spirea Lane, is hereby renewed.

**SECTION 2.** The costs of such lighting district shall be assessed against each parcel of real estate by the following method: in an equal amount against each benefitted lot bounding and abutting on the street and public ways so lighted, at the rate of \$8.13 per lot per year.

**SECTION 3.** The assessment for such lighting shall be paid in ten equal annual installments and shall be paid and collected in the same manner in which real estate taxes are paid and collected.


**SECTION 4.** The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.


**SECTION 5.** This Resolution shall take effect on the earliest date allowed by law.




