WHEREAS, Strawser Construction, Inc. submitted the lowest and best bid under the state bidding requirements of which Sycamore Township is a member for the 2019 Cape Seal Road Repair Project;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

# **SECTION 1.**

The Board of Township Trustees approves the 2019 Cape Seal Road Repair Project and the roads included therein. The Township shall pay one hundred percent (100%) of the cost of the project with no assessment for any property owner.

# **SECTION 2.**

The attached proposal for the 2019 Cape Seal Road Repair Project from Strawser Construction, Inc. in the amount of \$227,457.90 is hereby accepted and approved and the Township Administrator is hereby authorized and directed to contract with Strawser Construction, Inc. to provide for the 2019 Cape Seal Road Repair Project.

# **SECTION 3.**

The contract with Strawser Construction, Inc. shall provide all of the necessary requirements in accordance with the proposal submitted by Strawser Construction, Inc.

#### **SECTION 4.**

Subject to additions and deletions contained therein, the contract price with Strawser Construction, Inc. shall not exceed \$227,457.90.

**SECTION 5.** 

The Township Trustees of Sycamore Township, upon at least a majority vote, do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

This Resolution shall take effect on the earliest date allowed by law.
