- **SECTION 1.** The attached proposal for the Station 93 Mobile Radios and Hardware to go with the Locution System from Motorola Solutions in the amount of \$11,099.77 is hereby accepted and approved. The Township Administrator is hereby authorized and directed to contract with Motorola Solutions to provide mobile phones and hardware to be used with the Locution Dispatch System.
- **SECTION 2.** The contract with Motorola Solutions shall provide all of the necessary requirements in accordance with the proposal submitted by Motorola Solutions on the Ohio Cooperative Purchasing Program.
- **SECTION 3.** Subject to additions and deletions contained therein, the contract price with Motorola Solutions shall not exceed \$11,099.77.
- **SECTION 4.** The Township Trustees of Sycamore Township, upon at least a majority vote, do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
- **SECTION 5.** This Resolution shall take effect on the earliest date allowed by law.
