# A RESOLUTION APPROVING AND AUTHORIZING A CONTRACT WITH DAVE KING CONSTRUCTION FOR STONE MASONRY WORK FOR THE BECHTOLD PARK SHELTER 4 PROJECT AND DISPENSING WITH A SECOND READING

WHEREAS, the Board of Township Trustees determined to make improvements to shelters in Bechtold Park and;

WHEREAS, and in pursing that goal has caused plans specifications to be prepared for the reconstruction of shelter 4 in Bechtold Park (the Bechtold Park Shelter 4 Project) and has followed the procedure set forth in Ohio Revised Code for selection of a contractor for the stone masonry work for the Bechtold Park Shelter 4 Project; and;

WHEREAS, Dave King Construction submitted a proposal of \$20,000.00 in accordance with the specifications prepared by the Township; and

WHEREAS, the Board of Township Trustees wishes to determine to further proceed with the project and award the bid for the stone masonry work for the Bechtold Park Shelter 4 Project to Dave King Construction;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

#### **SECTION 1.**

The attached proposal from Dave King Construction for the stone masonry work for the Bechtold Park Shelter 4 Project is hereby approved and the Township Administrator is hereby authorized and directed to contract with Dave King Construction for the stone masonry work for the Bechtold Park Shelter 4 Project as set forth in the specifications prepared by the Township for the project.

#### **SECTION 2.**

Such contract shall provide that Dave King Construction shall provide and furnish all the labor, materials, tools, expendable equipment, and all utility, insurance and transportation services required in accordance with the specifications prepared by the Township, which specifications shall be made a part of such contract.

#### **SECTION 3.**

Subject to the additions and deletions contained therein, the contract price with Dave King Construction shall not exceed \$20,000.

#### **SECTION 4.**

The Board of Township Trustees of Sycamore Township, by at least twothird vote of all its members, dispenses with any requirement that this Resolution be read on two separate days and authorizes its passage upon one reading.

**SECTION 5.** 

This Resolution shall take effect on the earliest date allowed by law.
