The Trustees of Sycamore Township hereby finds that the 2018 Exmark Turf Tracer currently owned by Sycamore Township is obsolete and unfit for public use. The Township Administrator and Township Road Superintendent are hereby authorized and directed to dispose of the unit in accordance with any method of disposal authorized by the Ohio Revised Code Section 505.10.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

This resolution shall take effect on the earliest date allowed by law.
