**RESOLUTION NO. 2014 - 56**

**A RESOLUTION ESTABLISHING NEW RATES OF PAY FOR NEWLY PROMOTED  
TOWNSHIP EMPLOYEES, DISPENSING WITH THE SECOND READING, AND  
DECLARING AN EMERGENCY**

**WHEREAS**, the Board of Township Trustees of Sycamore Township has promoted Greg Bickford as the full time Township Administrator of Sycamore Township and the Board wishes to establish the salary for this position; and

**WHEREAS**, the Board of Township Trustees of Sycamore Township has promoted Rob Penney as the full time Chief of the Sycamore Township EMS and Fire Department and the Board wishes to establish the salary for this position

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** The portion of Section 2 of Resolution 2013 - 202 which reads as follows:

“Bickford \$82,625.78/year”

is hereby deleted. Substituted in its place effective May 15, 2014 is the following:

“Bickford \$95,000.00/year”

## SECTION 2.

The portion of Section 3 of Resolution 2013 - 202 which reads as follows:

“Penny \$80,961.26/year, plus uniforms, plus use of emergency automobile”

is hereby deleted. Substituted in its place is the following:

“Penny \$87,000.00/year, plus uniforms, plus use of emergency automobile”

### SECTION 3.

All other provisions of Resolution 2013 - 202 not amended herein or previously amended shall remain in full force and effect.

**SECTION 4.**

These annual salary amounts shall be prorated over the remaining payroll periods for the year commencing May 15, 2014, and shall not be retroactively adjusted to January 1, 2014. In the case of Bickford, it shall be prorated over the year May 15, 2014 through April 30, 2015. In the case of Penny, it shall be prorated to the end of calendar year 2014.

**SECTION 3.**

The Trustees of Sycamore Township, upon at least a majority vote, dispense with any requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

**SECTION 4.**






