**RESOLUTION 2017-45**

**A RESOLUTION AUTHORIZING THE 2017 RECLAMITE ROAD REPAIR PROJECT  
AND DISPENSING WITH A SECOND READING**

**WHEREAS**, the Board of Township Trustees is desirous of making improvements and repairs to certain township roads in Sycamore Township by use of the Reclamite road repair method (the “2017 Reclamite Road Repair Project”); and

**WHEREAS**, the Board wishes to order plans and specifications for the 2017 Reclamite Road Repair Project to be prepared;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** That the Board hereby approves the improvements and repairs for the 2017 Reclamite Road Repair Project, which consists of the entire length, unless otherwise noted, of the following roads in Sycamore Township: Trebor Drive, Tramore Drive, Tralee Court, Mantell Avenue (from Larchview Drive to Tramore Drive), Mantell Avenue (from Wexford Avenue to Darnell Lane), Killarney Court, Glengary Lane, Glenburny Lane, Eldora Drive (from Belfast south to the terminus), Belfast Avenue (from Mantell Avenue west to the terminus), Beech Avenue (from Kugler Mill to the southern corporation line), Antrim Court, Wexford Avenue (from Donegal Lane to the north terminus), Myrtle Avenue, Lake Avenue, Donegal Drive (from Wexford to the eastern terminus), Darnell Ave (from Mantell Avenue to Mantell Avenue), Yakima Drive, and Silvercrest Drive

**SECTION 2.** The Board hereby determines that the entire cost of the project shall be paid by the Township with no assessments to be made, and approves the preparation of plans and specifications for the project.

**SECTION 3.** The Board of Township Trustees of Sycamore Township, by at least two-third vote of all of its members, dispenses with any requirement that this Ordinance be read on two separate days and authorizes its passage upon one reading.


**SECTION 4.** This Resolution shall take effect on the earliest date allowed by law.


