

RESOLUTION NO. 2017-159

**A RESOLUTION ESTABLISHING RATES OF PAY AND BENEFITS
FOR TOWNSHIP EMPLOYEES AND DISPENSING WITH THE SECOND READING**

WHEREAS, in order to establish rates of pay and benefits for employees of Sycamore Township;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. All full-time employees of Sycamore Township shall receive medical, dental, and life insurance benefits, vacation time, sick days, and personal days as established in the Employee Handbook as it may be amended from time to time except union employees shall receive benefits per their union contract if such benefits differ from the Employee Handbook.

SECTION 2. The following employees shall receive the compensation and benefits set opposite their respective names effective on January 1, 2018:

This resolution shall take effect immediately making the rates of pay effective on the date indicated.






