**RESOLUTION NO. 2024 - 153**

**A RESOLUTION ESTABLISHING RATES OF PAY AND BENEFITS  
FOR TOWNSHIP EMPLOYEES**

**WHEREAS**, in order to establish rates of pay and benefits for employees of Sycamore Township;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** All full-time employees of Sycamore Township shall receive medical, dental, and life insurance benefits, vacation, sick, and personal time as established in the Employee Handbook.

## **SECTION 4.**




