RESOLUTION 2025 - 105

**A RESOLUTION DESIGNATING NO PARKING ON A PORTION OF
TIMBERKNOLL DRIVE IN SYCAMORE TOWNSHIP AND DISPENSING WITH A
SECOND READING**

WHEREAS, in order to provide for safe streets and roads in Sycamore Township, Ohio;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. Due to indiscriminate parking and to ensure the free movement of vehicles and emergency vehicles on Timberknoll Drive, a dedicated road in Sycamore Township, there shall be no parking on the south side of Timberknoll Drive starting at a point approximately four hundred and seventy feet (470') east of Shadetree Drive, extending east through and including the cul-de-sac, thence continuing to a point approximately thirty feet (30') on the north side of Timberknoll Drive, said point being the No Parking School Days Sign.

SECTION 2. The Township Maintenance Department shall install the appropriate signage as required by law to enforce this Resolution.

SECTION 3. The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days and hereby authorize the adoption of this resolution upon its first reading.

SECTION 4. That the Board finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. This resolution shall take effect on the earliest date allowed by law.






