Tuesday, June 17, 2025, 6:00 p.m.

The regular meeting was called to order at 6:00 p.m. by Chairman Schwegmann.

Present for the meeting were Chairman Schwegmann, Vice Chairman Weidman, Trustee Kellums, Fiscal Officer Deters, Law Director Barbiere, Administrator Bickford, Planning & Zoning Administrator Uckotter, Fire Chief Penny, and Sgt. Tony Crider from the Hamilton County Sheriff's Office. Superintendent Reutelshofer was absent.

An invocation was given by Mr. Kellums followed by the Pledge of Allegiance to the Flag.

Public Comments

Xiaohong (Hannah) Feng, of 8579 Hermitage Lane, Sycamore Township, Bonnie Pang, of 8433 Miami Road, Sycamore Township, and Kangming Ma, of 8509 Twilight Tear Lane, Symmes Township, addressed the Board. They expressed concerns about Ohio HB1 and SB88, which include proposals to ban immigrants from certain countries designated as foreign adversaries who are not U.S. citizens from owning property in Ohio within 25 miles of critical infrastructure. They stated the proposed bills are discriminatory without regard for members of the community and harmful to the future of Sycamore Township. Ms. Feng provided the Board with a handout about this issue. Ms. Pang spoke about her concern for young people. Mr. Ma said that such bills are intended to enhance homeland security but instead encourage hate. All three speakers asked the members of the Board to contact State legislators and urge them to vote no on Ohio HB1 and SB88.
