Minutes of the Regular Meeting of the Trustees of Sycamore Township Sycamore Township, Hamilton County, Ohio

August 2, 2022

The regular meeting was called to order at 7:00 pm. by Chairman Weidman.

Present for the meeting were Chairman Weidman, Vice Chairman Schwegmann, Trustee James, Interim Law Director Barbiere, Fiscal Officer Porter, Interim Administrator / Superintendent Kellums, Planning & Zoning Administrator Miller, Fire Chief Penny, and Cpl. Kidd from the Hamilton County Sheriff's Office.

The invocation from Pastor Larry Cornett at Bethel Baptist Temple was read by Mr. Kellums.

Pledge to the Flag.

Approval of the July 13, 2022 Zoning Public Hearing (Case 2022-10Z) Minutes

The July 13, 2022 Zoning Public Hearing minutes were presented for approval. Mr. James made a motion, seconded by Ms. Schwegmann, to accept them.

Mr. Porter called roll. Vote: Mr. James: Aye; Ms. Schwegmann: Aye; Mr. Weidman: Aye

Approval of the July 13, 2022 Special Trustees Meeting Minutes

The July 13, 2022 Special Trustees Meeting minutes were presented for approval. Mr. James made a motion, seconded by Ms. Schwegmann, to accept them.

Mr. Porter called roll. Vote: Mr. James: Aye; Ms. Schwegmann: Aye; Mr. Weidman: Aye

Public Comments

Mr. Weidman stated he would like to move public comments to later on the agenda as there may be someone coming to speak.

Mr. Miller said no one else had signed up to speak.

Sheriff Patrol Report

Cpl. Kidd stated he had no report.

EMS/Fire Report

Chief Penny reported Fire Department personnel had a meeting with Jim Craycroft at the Kenwood Collection and conducted fire training to create an evacuation plan for their building.

Ms. Schwegmann thanked Mr. Kellums for sending the Board EMS/Fire and Police run reports.

Roads, Maintenance & Recreation Report

Mr. Kellums reported both the Kenwood Meadows and Larchview Drive Projects are running on time and stated Sycamore Township Project Inspector Tony Perkins is doing a really good job.

Mr. Kellums said the members of the maintenance crew who had been helping with tornado cleanup in Goshen Township are now back working in Sycamore. He noted the Goshen community is very thankful for the help neighboring municipalities provided.

<u>Resolution</u> – Approving an LPA Federal Local-Let Project Agreement for the Sycamore Township Kemper Road Sidewalk (HAM CR 266 14.97) Project

Mr. Kellums reported the Township was awarded a grant for the Kemper Road Sidewalk Project and must pass a resolution approving an agreement with ODOT to proceed.

The resolution "Approving an LPA Federal Local-Let Project Agreement for the Sycamore Township Kemper Road Sidewalk (HAM CR 266 14.97) Project and Dispensing with the Second Reading" was presented by Mr. Kellums. Mr. James made a motion to approve the resolution, seconded by Ms. Schwegmann. Mr. Porter called roll. Vote: All Aye. Resolution 2022-076 passed this 2nd day of August, 2022

<u>Resolution</u> — Approving and Authorizing a Contract for the Illuminated Street Name Sign Project

Mr. Kellums reported he had a resolution for the Board's consideration to install additional illuminated street name signs at intersections along Kenwood Road to American Way and On Montgomery Road from Ken Arbre to Galbraith Road. He said the Township solicited bids for this project and received three responses. He reported Capital Electric Line Builders, Inc. submitted the lowest bid at 13% below the engineer's estimate for the project.

The resolution "Approving and Authorizing a Contract for the Illuminated Street Name Sign Project and Dispensing with a Second Reading" was presented by Mr. Kellums. Mr. James made a motion to approve the resolution, seconded by Ms. Schwegmann. Mr. Porter called roll. Vote: All Aye. Resolution 2022-077 passed this 2nd day of August, 2022

Planning & Zoning Report

Mr. Miller reported an Open House is scheduled for August 9th at 6:00 p.m. for a proposed zone change and SPUD review for the new campus associated with Kids First Sports Center on the west side of Solzman Road up to Old Solzman. He said the proposal includes a day care center and shared a conceptual plan on screen.

Mr. Miller reported Zoning Case 2022-12P1 for 7251 E. Kemper Road which proposes an addition to the existing ARKU manufacturing and storage facility. He noted there is no change to the ISR, and the case will require a PUD1 with Zoning Commission approval only.

Mr. Miller reported Zoning Case 2022-11MA for 4650 E. Galbraith Road, Landmark Recovery. He stated the property is the existing Carriage Court, 119 bed, assistant living and memory care facility. Mr. Miller reported Landmark Recovery is proposing a 136 bed, inpatient, and outpatient substance abuse treatment facility. He noted this is a major adjustment to the existing PUD.

Ms. Schwegmann asked if the request is to transform the existing assisted living.

Mr. Miller answered it is a change of use with an interior remodel only.

Resolution - 4105 Estermarie Drive Nuisance Property

The resolution "Providing for and Authorizing Removal of Vegetation, Garbage, Refuse and Other Debris and Declaring a Nuisance for the Property Located at 4105 Estermarie Drive, Sycamore Township, HAM OH 45236" was presented by Mr. Miller. Mr. James made a motion to approve the resolution, seconded by Ms. Schwegmann.

There was discussion about the need to correct a typo in the property address on the first page of the resolution.

Mr. James amended his motion to approve the resolution as corrected. Ms. Schwegmann seconded the motion, dispensing with a second reading. Mr. Porter called roll. Vote: All Aye. Resolution 2022-078 passed this 2nd day of August, 2022

Resolution - 3969 Larchview Drive Nuisance Vehicle

Mr. James made a motion to approve the resolution, seconded by Ms. Schwegmann, dispensing with a second reading. Mr. Porter called roll. Vote: All Aye.

Resolution - 11988 5th Avenue Nuisance Property

The resolution "Providing for and Authorizing Removal of Vegetation, Garbage, Refuse and Other Debris and Declaring a Nuisance for the Property Located at 11988 5th Avenue, Sycamore Township, HAM OH 45249" was presented by Mr. Miller.

Mr. Miller noted the same error was in this resolution and stated he will have to check with CAGIS as there must be an issue with the values of the documents being generated by their system.

Mr. James made a motion to approve the resolution with the correction to reflect Sycamore Township, Hamilton County Ohio 45249 in each place where it appears as HAM OH OH. Ms. Schwegmann seconded the motion, dispensing with a second reading. Mr. Porter called roll. Vote: All Aye.

Resolution 2022-080 passed this 2nd day of August, 2022

Resolution - 11988 5th Avenue Nuisance Vehicle

The resolution "Providing for the Removal of Junk Vehicle in Sycamore Township, Hamilton County and the Proper Disposal, Storage or Impoundment of Motor Vehicle by Implementing the Procedures Set Forth in Sycamore Township Resolution 2012-14, and Sections §§ 505.173, 505.85, and 505.871 of the Ohio Revised Code" was presented by Mr. Miller. Mr. James made a motion to approve the resolution, seconded by Ms. Schwegmann, dispensing with a second reading.

Mr. Kellums pointed out the same address issue in section 1 of this resolution.

Mr. James amended his motion to include the correction of the address to reflect Sycamore Township, Hamilton County Ohio. Ms. Schwegmann seconded the motion, dispensing with a second reading. Mr. Porter called roll. Vote: All Aye.

Resolution 2022-081 passed this 2nd day of August, 2022

Mr. Miller reported Zoning Commission meets August 8th at 6:00 p.m. and the Board of Zoning Appeals meets the following Monday, August 15th at 6:30 p.m.

Mr. James said he was going to have a question about a discussion he and Mr. Miller had last week about a property still under construction that needed cleaning. He stated he drove by the property on the way to the meeting and noticed much of it had been cleaned. He said he sees Mr. Gregg Fusaro is here and perhaps he will speak about that. He said residents have been asking about the property and thanked Mr. Fusaro.

Public Comments

Mr. Weidman said he would like to proceed with the Public Comment agenda item and invited Mr. Fusaro to address the Board. He noted he had spoken to Mr. Fusaro several times about the issues on the site.

Mr. Gregg Fusaro, 6745 Kenwood Road, addressed the Board regarding issues on the construction site across from Kenwood Towne Centre. Mr. Fusaro stated they have made great progress with construction although not as good as hoped initially due to material shortages and logistics issues which have led to their construction timeline being four months behind the original estimate.

Mr. Fusaro reviewed a list of items still in progress on the site noting the landscapers have been on site several times and will be back. He said they recently hired a company to maintain the landscaping. He said he hopes to have landscaping counted and complete in the next few weeks noting anything that is dead will be replaced.

Mr. Fusaro addressed the issue with the retaining pond holding water which he said is caused by a significantly higher volume of water being taken on than anticipated. He explained the plan the subcontractor, Worksite Solutions, has to remedy the issue.

Mr. Fusaro said the good news is the property is 70% leased and 53% occupied. He reported they have leased 200 units in four months which is a testament to the location and the quality of the product. Mr. Fusaro said they are planning a Grand Opening event in late September.

Mr. Fusaro reported Corporex is constructing a Residence Inn on the site with an estimated completion of July, 2023. He said they hope to have the white box completed for the restaurant, Condado, in March 2023 and they will open in October or November, 2023.

Mr. Fusaro said the third portion of the project was slated to be an office building. He noted that landscape has changed significantly since the pandemic with the move toward remote work. Mr. Fusaro said they are looking at several different ways to get that developed as quickly as possible noting any change to the original zoning approval would have to come back before the Board of Trustees. He pointed out since there will not be 120,000 square feet of office, there will be a lot less traffic generated by the development than originally anticipated.

Mr. Kellums asked if the landscape maintenance company Mr. Fusaro hired was asked to maintain the residential side of the property.

Mr. Fusaro answered yes and discussed the practical issues with getting access to the adjacent properties to maintain the landscaping due to fencing on both properties and the width of the evergreen trees. He stated the area is irrigated and they will do the best they can to maintain it.

Mr. James commented he walked back there and could see that work had been done.

Ms. Schwegmann said there was a fence around the office pad and asked if another fence would be installed.

Mr. Fusaro answered a chain link fence will be erected within the next few weeks.

Mr. James said the right of way adjoining Jewish Hospital on Happiness Way across from the development needs maintenance.

Mr. Kellums requested Mr. Fusaro have the contractor remove the plastic that held down the straw so that area may be mowed.

The Board thanked Mr. Fusaro for addressing these issues.

Law Director Report

<u>Resolution</u> – An Emergency Resolution to Accept the Terms of the Distributor Settlement Participation Agreement and Janssen Settlement Participation Agreement Pursuant to the OneOhio Memorandum of understanding and Establishing a Separate OneOhio Special Fund Under R.C. §5705.09(F) to Receive Such OneOhio Funds

Mr. Barbiere reported as part of the settlement agreement the State of Ohio entered into with National Opioid Distributors for over \$800 million, Sycamore Township will receive \$90,891.36 over a number of years. He stated one of the requirements of receiving that money, is that the money be put into a special fund, and there are limitations as to how that money may be spent. He said the limitations are set forth on Exhibit C of the resolution, but in a nutshell the money must be spent to prevent substance abuse, treat substance abuse and things of that nature. Mr. Barbiere said he had a resolution for the Board's consideration which will accept the terms of the settlement; create the new fund; and states the Fiscal Officer will make sure the funds will only be expended for purposes allowed by the Auditor.

The resolution "An Emergency Resolution to Accept the Terms of the Distributor Settlement Participation Agreement and Janssen Settlement Participation Agreement Pursuant to the OneOhio Memorandum of understanding and Establishing a Separate OneOhio Special Fund Under R.C. §5705.09(F) to Receive Such OneOhio Funds" was presented by Mr. Barbiere. Mr. James made a motion to approve the resolution, seconded by Ms. Schwegmann.

Mr. Weidman asked if the funds may be used retroactively for medications already purchased.

Mr. Barbiere answered he does not believe so.

Mr. Weidman thanked Tracy Schwegmann for representing all the Townships in Hamilton County by serving on the OneOhio Board for Hamilton County.

Ms. Schwegmann thanked the Board for expediting the process.

Mr. Porter called roll. Vote: All Aye.
