Minutes of the Regular Meeting of the Trustees of Sycamore Township Sycamore Township, Hamilton County, Ohio

Tuesday, September 17, 2024, 7:00 p.m.

The regular meeting was called to order at 7:00 p.m. by Chairman Weidman.

Present for the meeting were Chairman Weidman, Vice Chairman Schwegmann, Trustee Kellums, Fiscal Officer Deters, Law Director Barbiere, Administrator Bickford, Superintendent Reutelshofer, Planning & Zoning Administrator Uckotter, Fire Chief Penny, and Lt. Naber from the Hamilton County Sheriff's Office.

The invocation was read by Mr. Kellums.

## Approval of the September 3, 2024 Trustee Minutes

#### **Public Comments**

Ms. Shirley Wilkerson, of 4526 Elizabeth Street, addressed the Board in regard to issues she is having with neighbors on her street that she views as harassment.

Mr. Brian Haigh, of 4106 Jud Drive, addressed the Board regarding housing court proceedings for violations on his property. He spoke in favor of repealing home rule zoning.

## **Sheriff Patrol Report**

Lt. Naber reported school is back in session and encouraged people to be mindful of children going to and coming home from school.

## **EMS/Fire Report**

Chief Penny reported the Fire Department will have its ladder truck at the Touch a Truck Event and a crew to assist with the helicopter.

## Planning & Zoning Report

Mr. Uckotter reported that the demolition of the condemned house on 3rd Avenue began on Monday. He noted that the rear had to be cleared to provide access for Duke Energy, and demolition will begin in earnest on Thursday.

Mr. Uckotter reported he and his staff are currently working on the implementation of the new zoning software.

#### Resolution - Nuisance Vehicle Resolution

The resolution "Providing for the Removal of Junk Vehicles in Sycamore Township, Hamilton County and the Proper Disposal, Storage or Impoundment of Motor Vehicles for the Property Located at 11921 Fourth Avenue, Sycamore Township, Ohio 45249 by Implementing the Procedures Set Forth in Sycamore Township Resolution 2012-14, and Sections §§ 505.173, 505.85, and 505.871 of the Ohio Revised Code" was presented by Mr. Uckotter.

Mr. Uckotter noted the owner had not responded to attempts to contact them and the registration was confirmed to have expired several years ago.

## Roads, Maintenance & Recreation Report

Mr. Reutelshofer reported the Sycamore Township Touch a Truck event will be held on Saturday, September 28th, from 10:00 a.m. to 2:00 p.m. at the Sycamore Township Administration Building back parking area. He said there will be fire trucks, maintenance vehicles and equipment, Sheriff vehicles, SWAT vehicles, a K9 Unit, a drone demonstration, the UC Air Care helicopter, face painting, music, and games for the kids, and food trucks. He noted more information is available on the Township website at sycamoretownship.org.

Mr. Reutelshofer reported that the Euclid Sidewalk Project is almost 50 percent complete. He stated after a few delays starting the project, the contractor is now making good progress, and it is on schedule to be completed in November.

Mr. Reutelshofer reported that the contractor for the Kenwood Improvement Project will begin curb replacement next week and advised the public to be aware of lane closures and heavy construction activity between Montgomery Road and Galbraith Road. He stated residents should expect busy construction activity on Kenwood Road from now until mid-November. He noted the project will shut down for the holiday shopping season.

Mr. Reutelshofer reported there is a purchase order for the Board to consider later in the meeting for engineering and architectural services to develop a conceptual sketch including architectural renderings and a preliminary cost estimate for a single-user restroom and shower addition at the maintenance facility at Schuler Park. He stated there is currently no water or sewer service back to the maintenance facility which is used by at least two employees on a daily basis most of the year. He noted the Township has contracted with Cintas to provide emergency wash stations.
