RESOLUTION AUTHORIZING THE TRANSFER OF FUNDS FROM THE SYCAMORE TOWNSHIP, HAMILTON COUNTY CIC, INC. TO SYCAMORE TOWNSHIP

WHEREAS, on April 5, 2022 at a special meeting of the Board of the Sycamore Township, Hamilton County CIC, Inc., (CIC) the Board voted to authorize the CIC Executive Director to commence negotiations for the sale of property located at 11745 Solzman Road which had been transferred to the CIC from Sycamore Township; and

WHEREAS, on June 29, 2022 the aforementioned property was sold to Kemper Road Backlot, LLC; and

WHEREAS, after the closing on the property, the amount received by the CIC totaled \$117,465.75; and

WHEREAS, the CIC now finds it necessary to transfer funds in the amount of \$117,465.75 to Sycamore Township.

- 1. The CIC hereby authorizes the transfer of funds in the amount of \$117,465.75 to Sycamore Township for the sale of property located at 11745 Solzman Road.
